# Scholarship purpose and description

We provide scholarships with the aim of contributing to more equity in access to trauma-informed skills and embodiment practices and spaces for underrepresented minorities and marginalized individuals.

These scholarships aim to:

a) Increase diversity and inclusivity amongst SomaPsych and Legacy Motion's community b) Encourage and invest in facilitators in underrepresented communities, that can encourage the establishment of more specific trauma-informed skills and embodiment practices and spaces for such communities

c) A small contribution to more socially just structures and changes needed in our global access to somatic and trauma informed spaces

# Scholarship eligibility criteria

1) People from low-economy countries and financially marginalized communities, who otherwise would be unable to access this training

2) Underrepresented minorities to include, but are not limited to: refugee/asylum seekers, LGBQTIA+, have a lower socio-economic status or background, have lived experience of homelessness, disability or disadvantage

#### Why?

We live in unjust and unfair structures and systems of power and privilege. This means there are barriers to accessing services, including trauma-informed practitioners and embodiment practice spaces. In a commitment to social justice, and to our global community, we strive to break down some of these barriers via investing in underrepresented minorities in this space.

We aim to contribute to inclusivity, accessibility and diversity by investing in practitioners who can provide further access to their own underrepresented or marginalized communities. This also is a gift to the trauma-informed practitioner community, if such individuals should choose to bring their voice, wisdom and experience to further educate and broaden the understanding of safe(r) spaces and embodiment for all.

We take seriously our responsibility to our global community and strive to offer these scholarships as a small (but albeit necessary) part of more socially just and diverse communities.

#### Should I apply?

This scholarship might be something you consider if you fit the above criteria and are looking for: further occupational skills for your place of work, adding trauma-informed practices into your community, or have a plan for how you'd like to utilize these skills through offerings for underrepresented minorities.

These scholarships aim to contribute to a more inclusive culture in who has access to holding and entering trauma-informed spaces. Specifically, we would love to support individuals with a vision to use this opportunity to provide access to these spaces for minority groups / their community.

Note: this opportunity is not for personal trauma resolution.

If you acknowledge that your social position isn't underrepresented in this space, please respect that this opportunity isn't for you. This opportunity acknowledges and elevates systemically marginalized individuals. Therefore, this applies even if the community you serve is underrepresented. This scholarship is specifically for underrepresented individuals.
